Research Showcase Event Details

Purpose | Prisma Health celebrates research and scholarly activity that are competitively selected annually at the Prisma Health Education and Research Institute Showcase. This continuing learning opportunity hosts a scientifically diverse spectrum of basic and clinical research and quality improvement activities aligned with Prisma Health priorities and goals. Through the Showcase, Prisma Health with its academic partners (Clemson University, Furman University, and University of South Carolina) seeks to encourage comradery and collaboration producing evidence informing clinical practice. The Showcase also provides a venue for individuals to refine their peer-reviewed presentation skills.

Eligibility | Affiliated clinicians and academicians (Prisma Health, Clemson University, Furman University, and University of South Carolina) and their students, residents, and fellows.

Abstract Submission

Submission deadline | Monday, September 4 by 11:30 p.m.

General abstract/project information

- Completed projects or projects in progress may be submitted for poster presentation.
- Abstracts may highlight original research, quality improvement projects, evidence-based practice, or programmatic innovations.
- Abstracts presented elsewhere or published within the past 12 months are showcase eligible. However, scholarship should be updated for Research Showcase presentation.
- The corresponding author listed in the abstract submission is the sole recipient of all abstract/project-specific communications. The corresponding author is the only individual that may update the abstract submission form. If the abstract is selected for poster presentation, the corresponding author is the only individual that may upload the digital poster.
- It is recommended that an investigator present only one poster during the event. Investigators leading multiple projects/posters should solicit their co-investigators to present additional posters. It may not be possible to place posters adjacent to each other when presenting more than one project.
- A confirmation email will automatically be generated by the system to the email provided for the corresponding author once the abstract is submitted. If an email is not received, contact Dr. Rebecca Marigliano.
- Only complete and instruction-compliant abstract submissions will be reviewed.

Abstract submission guidelines

- Abstracts must be submitted electronically through the Prisma Health Research Showcase submission [website](#).
- The abstract text may not exceed 450 words (not including abstract/project title and author names).

Abstract elements | The following elements must be included in the abstract text:

- Purpose statement (*goal of the project*)
- Methods (*brief description of study design and methods*)

- Results (*key findings*)
- Conclusion (*explication of findings applicability to health care*)

Each of the above elements must be specifically identified as subject headers within the abstract. For example, each submitted abstract should have “Purpose statement”, “Methods”, “Results”, and “Conclusion” within the text prior to the exposition of the element. Authors may include additional information (e.g., introduction, background, limitations, sources of support) at their discretion.

Category selection | Investigators must select one of the following categories that best describes their project:

- Innovations in Health Care Delivery – *Examples, Telemedicine, remote monitoring, artificial intelligence, virtual reality, and point-of-care diagnostics*
- Quality & Safety / Human Factors / Process Improvement – *Examples, Quality improvement/patient safety/high value care projects; Cost containment projects; Value-payment projects*
- Population and Community Health – *Examples, Biological and social determinants and their impact on patient/community health outcomes and providers; Mental and behavioral health challenges; Community, school, and faith-based health centers; Health disparities*
- Developing and Supporting the Health Care Workforce – *Examples, Interprofessional training; Well-being, burnout, and performance of the workforce*
- Basic Science and Translational Research – *Example, Basic scientific inquiry with potential to advance diagnosis and treatment and improve health*

Notification of presentation | The Abstract Review Committee will select submitted abstracts for poster presentation utilizing the [abstract review rubric](#). Notification of presentation will occur no later than Friday, September 22, 2023.

Poster Guidelines

Poster presentations | Investigators will present both a digital (electronic) poster and physical (display) poster. Following notification of poster presentation, digital posters must be uploaded to event [website](#) by Monday, October 16, 2023, at 11:30 p.m. Only the identified corresponding author will be able to upload the digital poster into the system. Posters/uploads received after the deadline will not receive a review and will be deemed ineligible for awards. Awards will be selected based on the review of the digital posters utilizing the [poster review rubric](#).

Digital poster specifications | The poster must be uploaded as either a JPEG, PNG, or PDF file. If using PowerPoint, access “File”, use “Save As”, and then select JPEG, PNG, or PDF formats using the dropdown box under the file name. The file size must be 30MB or less.

Poster display specifications | Posters should be no greater than 36” high by 48” wide. Presenters may distribute handouts or other materials to complement their display.

Poster templates | Prisma Health poster templates and printing instructions are available [here](#) – Prisma Health login required to access. Otherwise, any academic poster template suitable for scientific presentation may be used.

Day of event | The poster display area will open at 10:30 a.m. on Friday, October 27, 2023, for presenters to assemble posters. Posters require at least one author to present the poster during the presentation time (11 a.m. and 12:30 p.m.) The posters should be removed by 3:15 p.m. Posters that are not removed by 3:15 p.m. will be destroyed.

Awards

Awards ceremony | The awards ceremony will commence following the keynote address at 1:15 p.m. on Friday, October 27, 2023. Please ensure that at least one author remains at the event for the ceremony.

Oral presentations | Authors receiving an award will be invited to present their work orally during the virtual [Prisma Health Research Town Hall](#) on Wednesday, November 15, 2023, beginning at 8:30 a.m. Further details will be provided to the awardees shortly following the Research Showcase.
